### Camp Staff:

**Tom Borrelli** : CMU head coach and camp director.

- Led Chippewa wrestling program to 10 straight MAC titles and a 2009 season ranking as high as No. 5 nationally. 27 individual All Americans, Six top 15 team finishes.
- Nine-time MAC Coach of the Year

**Mark DiSalvo** : CMU assistant coach since 2007

- Three-time national qualifier; Two time All-American; Two time MAC Champion
- Regarded as one of the top NCAA assistants.

This team camp will provide 12 hours of instruction, drilling and technique. 6 Live wrestling sessions, Team Dual matches and individual tournaments. This camp cost \$250 on the CMU campus per athlete. You can get this at Lambert High for about \$50 per kid at the team rate.
